Certificate of Liability Insurance required

No alcoholic beverages, tobacco products, vaping, or drugs allowed.

Category 1:

- District- and school-sponsored events, athletics, meetings, booster clubs, PTA and activities.
- 501(c)(3) non-profit organizations providing academic services to BCSD students without charge.

Category 2: 501(c)(3) non-profit organizations and all governmental organizations operating within Blaine County (IRS Determination Letter required or paperwork certifying governmental status)

Category 3:

- For profit organizations
- Homeowners Association
- Religious organizations
- Any non-profit organization charging an entry/participation fee above \$200
- All non-BCSD fundraiser events
- WRHS Performing Arts Theater usage for all non-BCSD organizations(See WRHS Performing Arts Theater rate sheet)
- 501(c)(3) non-profit organizations and all governmental organizations operating outside of Blaine County (IRS Determination Letter required or paperwork certifying IRS or governmental status required)
